Crafters register now for the 34<sup>th</sup> Annual Holiday Craft Show. Exhibits are limited to hand-made items only. Commercially made items or flea market items will not be accepted. There will be a limited number of spaces for jewelry, scarves, crochet items, soaps and children’s dress-up for the 2019 show. All crafters must fill out a Craft Show Participation Contract. Set-up will take place on Friday, November 1, 2019 from 3:30 -7:00 pm. Each crafter will receive one chair per space and **must mail or e-mail in a picture of their booth set-up with their contract.** Spaces are limited to the first 50 space/applications received.

1. The exhibitor accepts all liability for federal, state and local taxes related to the operation of the said exhibit.
2. **The Annerino Community Center is a smoke free environment. Violation of this rule will result in the removal of your application from our files.**
3. Set up is between **3:30 – 7:00 pm** on Friday, November 1, 2019. No participant will be admitted to set up before or after these hours. **The gymnasium will re-open at 7:45 am on Saturday, November 2, 2019.**
4. Crafters are required to display and sell items during all craft show hours and removal of items may begin no earlier than 3:00 pm on Saturday, November 2, 2019.
5. Participants are expected to be at their tables **FIFTEEN MINUTES BEFORE AND DURING ALL SHOW HOURS.**
6. **Tables must be covered to the floor in front; promotion of your craft must not infringe upon other participants, therefore, when using freestanding backdrops, displays must be limited to your side only.**
7. **No white elephant or second hand items may be sold.**
8. **The exhibitor must handcraft all finished craft items. Please submit a picture of your booth set-up with your contract.**
9. The Gymnasium will be locked after the last crafter has set up or 7:00 pm which ever comes first. The Bolingbrook Park District cannot assume responsibility for your items at any time.
10. You are required to remove your craft booth by **4:30 pm** on Saturday, November 2, 2019.
11. Crafters selected to sell at the Bolingbrook Park District Holiday Craft Show must be over 18. For the safety of other crafters & shoppers, children 10 years & under are not permitted to work or stay in your craft show space during show hours.

The Bolingbrook Park District reserves the right to enforce the above guidelines. **NO REFUNDS** will be issued for cancellations received after Thursday, October 10, 2019. Any cancellation received *before Thursday, October 10, 2019* will be subject to a \$20.00 service fee.
